## 4. Staff Reports-Administrative Services

## i. Reopening Update

Superintendent Pelzel updated the Board on the reopening of schools and COVID-19 County updates. The current case positivity rate is down to 4.1, maintaining the County in the Red Tier. The District is waiting to hear whether school districts would be permitted to allow 3 feet vs 6 feet of social distancing, which would allow for full-time in-person instruction for most classrooms in the new school year.

District staff have initiated discussions on current and new school year plans, including how to address learning loss. The District also plans to survey families and staff to determine whether to move forward with an online academy in 2021-2022.

Stevenson Ranch Elementary parent Suverna Mistry addressed the Board about discussing social interaction opportunities for children by allowing safe outside playtime. In response, Superintendent Pelzel explained the challenges involved with the guidelines currently in place.

In response to Board member questions, staff discussed plans to possibly purchase new classroom furniture to address space issues. Board members directed staff to move as quickly as possible, as it is likely several districts will have similar needs.

Board members also stressed the importance of the District conveying the message in its communications that it plans to move towards full-day instruction in the fall.

# ii. Discussion and direction on providing an Online Academy option for NSD families in 2021-2022

As the District begins preparations for the 2021-2022 academic year, staff requested the Board provide direction on a remote learning option. Superintendent Pelzel proposed the two following options: the Home Study Program already offered to students on long-term leaves or a Distance Learning program similar to what is offered this year. In order to determine a need, the District will host informational meetings and survey families and staff.

Board members directed staff to be as transparent as possible with the two proposed options to avoid confusion. In addition, the District is to be clear that both models are secondary options to in-person learning.

## iii. Discussion and Direction on 2020-2021 School Effectiveness Survey Questions and Timeline

Board members previously reviewed survey questions in October 2020. Revisions to questions for the current year will include language related to the Distance Learning and Hybrid models.

Board members discussed and deliberated at length amending the current questions so that they address the unique distance-learning model available during the COVID-19 pandemic.

Board members agreed the District should include the three distance learning academies as separate schools.

The School Effectiveness Survey is scheduled to go out to families in early May.

Approved the 2020-2021 School Effectiveness Survey questions with amendments.
