Staff presented the following options for consideration:

Option 1: ASCIP recommends sites use City-run pools for their events Option 2: ASCIP recommends the District purchase a supplemental policy if sites choose to move forward with HOA-run pools. District staff secured two policy quotes for Board consideration.

Board members held discussions and a motion was made to purchase supplemental insurance from Sports Underwriters to support 6th grade end-of-year swim gatherings at HOA-run pools.
