Former Stevenson Ranch Elementary Principal Tim Lankford addressed the Board on issues associated with security and safety due to the lack of wireless services at the school site.

Community members Diane Zimmerman and Cindy Josten addressed the Board about considering formally celebrating Constitution Day throughout all school sites. Ms. Josten also addressed the Board on her opposition of a wireless tower in the Stevenson Ranch area.

Stevenson Ranch community member Annette Peterson provided a presentation referencing reports and evidence supporting her opposition of a proposed wireless tower near Stevenson Ranch Elementary. Ms. Peterson shared the next Planning Commission Public Hearing is scheduled for August 17, 2022 and requested the Governing Board oppose the cell tower via the approval of a resolution and District representation at the August 17 Public Hearing.

Dr. Hernandez shared that the District made several attempts to contact AT&T to request representation for today's meeting, but calls and emails were unreturned.

Assistant Superintendent of Business Services Sheri Staszewski shared history on the District's attempts to purchase cell phone-driven notification systems to address safety and security needs, but were unable to move forward due to poor cell/wireless reception in the Stevenson Ranch area.

SCV Public Safety and Security Services owner Daniel Rodriguez shared the difficulties of providing effective security services in the Steven Ranch area due to the lack of cell service and dead spots. Mr. Rodriguez shared how critical safety and emergency calls are in the first few minutes of an incident.

Board members agreed to move forward with an amended resolution. Board members also directed staff to contact Supervisor Barger's requesting support to have AT&T reconsider a different location for the wireless tower. Lastly, Board members directed staff to contact AT&T to request representation for the August 9th meeting.
