Assistant Superintendent of Instructional Services Kate Peattie shared that Benchmark Phonics is a new program based on the latest science of reading research. The program will be integrated with the District's current Benchmark Advance and Benchmark Adelante English Language Arts curriculum, and will be used in grades K -5.

Based on the results, the District will continue professional learning for all administrators, and teachers throughout the 2023-24 school year at the following sites; Newhall, McGrath, Wiley Canyon, and Peachland. Assistant Superintendent of Business Services Arik Avanesyans shared that the District's Governing Board is required to determine the use of the Education Protection Account (EPA) funds. Staff recommends the District utilize all funds for instructional purposes.

A resolution had not been previously approved in the 2022-23 fiscal year.

Assistant Superintendent of Business Services Arik Avanesyans asked the Board to consider committing all reserves in excess of twice the economic uncertainty amount of 3% required by the State. Committed funds may be taken out of a committed status by a subsequent Board resolution, but until that time, the funds may only be expended for the purposes included in this Resolution. This action is a requirement for adopting the 2023-2024 budget.

Assistant Superintendent of Business Services Arik Avanesyans shared school districts are required to obtain annual Governing Board approval for fund cash transfers primarily for temporary borrowing between funds for cash flow purposes. This is a common practice for school districts.

Assistant Superintendent of Business Services Arik Avanesyans shared that the Resolution allows the District to continue to participate in the statewide Joint Powers Agreement ("JPA") where it receives a portion of delinquent tax receivables assigned to the JPA. This resolution authorizes participation through June 30, 2025.
