iii. Consideration of Approving Use of a Piggyback Contract to Purchase Chromebooks for District Refresh and ELOP

The purchase will help replace aging student devices with new Chromebooks, focusing on a 6-year replacement cycle. Items will include 1100 Chromebooks with licenses for student use in classrooms and 714 Chromebooks with licenses for student use during the after-school programs.

Board member Solomon recommended the District look into redeveloping a District Master Technology Plan sometime in the future, which will help determine equipment inventory, shelf life, and anticipated budgets.
