2022-23 School Overview

Valencia Valley School is a California Distinguished School located in the City of Santa Clarita, and is one of ten schools in the Newhall School District (NSD). In a typical school year, Valencia Valley maintains an average enrollment of 689-744 students in grades UPK-6. Twenty two different languages are spoken by students and families of VV, and the school continues to become more and more diverse. Valencia Valley's student population is 50% White, 29% Hispanic, 6% Asian, 4% Filipino, 1% Black/African American and 10% other ethnicities. English Learners comprised about 7.7% of our student body. Valencia Valley also has the NSD SDC 3 Program, in which 31 students are currently enrolled. They share learning experiences with their general education peers as appropriate for their learning goals. Valencia Valley School consists of a core building housing classrooms, the library, multi-purpose room, science lab, and school offices. There are two outside buildings with fourth, fifth, sixth grade classrooms.

As part of the Newhall School District, students who attend NSD are provided with a comprehensive program which includes, music and art. In addition our campus provides both intervention and extension opportunities including WIN (What I Need), GATE, and Student Council. Teachers operate as a Professional Learning Community, studying students' academic and social performance. The data drives instructional decisions, including grouping students for WIN time and referral for further study or services such as (Student Support Team) SST and counseling services. We have a full time counselor who runs groups, sees students one-on-one and provides lessons to classes and grade levels.

Our PBIS program is grounded in a research based framework. Our PBIS program has made a positive impact at Valencia Valley Elementary in terms of student behavior and adult behavior. It is preventative, multi-tiered and equitable for ALL students. We have created a shared vision with a common language, shared beliefs about behavior, and common behavior expectations that are clear to staff and students. Our staff, parents, and students have worked collaboratively to create common behavior expectations at school and at home during distance learning. We are Vikings On a Quest to be Respectful, Responsible, and Safe. Teachers and staff have explicitly taught expectations to our students in each school setting including the home setting. PBIS incentives are offered for positive behavior choices and attendance.

School Facility Conditions and Planned Improvements

The Newhall School District is very concerned about the safety of our students, staff, parents, and community members. The following outlines the various steps the Newhall School District takes to ensure we have clean, safe, and well maintained schools.

Cleanliness

The Newhall School District provides custodial staffing so that every classroom at every school can be cleaned daily. We also clean all Preschools and Kindergarten bathrooms and offices on a daily basis. Our Director of Facilities, Maintenance, and Operations (FMO) routinely inspects our schools to ensure they are kept in a clean, safe and orderly condition. Our custodial staff has been directed to notify the school Principal or Office Manager of any safety hazard or maintenance issue that requires immediate attention. The Office Manager will submit a work order via our net-based work order program where the Director FMO reviews and distributes work orders to maintenance staff. Safety related work orders are labeled number one priority!

Weekly School Visits / Inspections

The Director FMO visits and inspects two schools every week

Security

We ask that all parents and visitors check in with the main office at each school. The district also utilizes a Visitor Management System (Raptor) to screen visitors. To assist staff in communicating on site, two-way radios are used by administrative staff, office staff, and safety supervisors. Each school provides playground supervision to ensure our students are properly supervised during recess and identify any safety or security concerns to the school administrative team.

Age of Schools

The Newhall School District includes 10 schools. Our newest school was constructed in 2005-2006. Eight schools are either less than 16 years old or have been "modernized" with local and State bond funds. "Modernization" may include utility infrastructure replacement, new carpeting, new lights, new windows and doors, new locks, new interior and/or exterior wall paneling, fire alarms, communications systems, internet infrastructure to all classrooms, storage, roof replacement, interior/exterior painting, library renovation, and bathroom renovation.

The district successfully passed Measure E, a \$60 million school construction and modernization bond, in 2011. Projects include the replacement of aging portable classrooms with permanent buildings, the renovation of Newhall Elementary School auditorium, upgrades to the district infrastructure including technology, energy management, communications and utility controls. A significant investment in classroom technology has been completed.

In the 2022-23 school year, we look forward to partnering with parents to re-imagine our school mission and vision. Together, families and school staff create the warm, caring, intentional environment for which Valencia Valley is known!

Our belief in strong parent involvement is backed by the District's Local Control Accountability Plan (LCAP). Under Parent Involvement, the plan calls for increased parent engagement (involvement in school programs/activities; feedback on school performance) through the following:

As part of the Newhall School District, Valencia Valley has a part time bilingual Community Liaison who works to help enhance communication between home and school. The Community Liaison's role includes translating orally or in writing during school hours as well as evening events, parent meetings, IEPs and various group meetings. Additionally, she answers questions, provides resources and helps build relationships between parents and various members of the school.

Our Site Supplemental allocation is used to support "What I Need" (WIN) time. During WIN, students are grouped across each grade level and teachers and support staff provide instruction the students' levels, based on grade level common formative assessments.
