Technology

New Closing the Digital Divide Task Force Announced

State Superintendent of Public Instruction Tony Thurmond announced a new task force to close the digital divide for California students who lack access to resources such as internet connectivity and devices. California State Senator Connie Leyva, the Chair of the Senate Education Committee, will co-chair this committee. The Closing the Digital Divide Task Force will help facilitate donations, create more publicity, and cast a bigger spotlight on those who can help. This task force plans to hold a public hearing where internet service providers may be called upon to testify on their efforts to improve internet access during the pandemic.

Supporting Students with Technology for the Computer Science Advanced Placement AP Exam

Funding

Highlighted Frequently Asked Question

Question: May a grantee or subgrantee continue to pay the compensation of an employee paid with grant funds from the Department during the period the employee is unable to work because his or her organization is closed due to novel Coronavirus Disease 2019 (COVID-19)?

Answer: Yes. Generally, a grantee or subgrantee may continue to charge the compensation (including but not necessarily limited to salaries, wages, and fringe benefits) of its employees who are paid by a currently active grant funded by the Department to that grant, consistent with the organization's policies and procedures for paying compensation from all funding sources, Federal and non-Federal, under unexpected or extraordinary circumstances, such as a public health emergency like COVID-19. Thus, if the organization pays, consistent with its policies and procedures, similarly situated employees whose compensation is paid with non-Federal funds during an extended closure, those paid with grant funds from the Department may also continue to be paid. However, an employee who is being paid with Department grant funds while the program grant activities are closed in whole or in part due to the COVID-19 pandemic may not also be paid for the time during which the program is closed by

the organization or another organization for working on other activities that are not closed down.

If a grantee or subgrantee does not currently have in place a policy that addresses extraordinary circumstances such as those caused by COVID-19, the grantee or subgrantee may amend or create a policy in order to put emergency contingencies in place for Federal and non-Federal similarly situated employees. If the conditions exist for charges to be made to the Federal grant, charges may also be made to any non-Federal sources that are used by a grantee or subgrantee in order to meet a matching requirement.

A grantee and subgrantee must maintain appropriate records and cost documentation as required by 2 CFR § 200.302 (financial management), 2 CFR § 200.430(i) (standards for documenting personnel expenses), and 2 CFR § 200.333 (retention requirements for records) to substantiate the charging of any compensation costs related to interruption of operations or services. At the same time, recipients should consider ways that employees paid with grant funds can support continuing activities, including distance learning opportunities for students served by the grant.

Interim Assessments Now Available to LEAs for Distance Learning

The CDE has opened the Smarter Balanced Interim Assessments for LEA staff to use as part of distance learning while schools are closed due to novel coronavirus disease 2019 (COVID-19).

How does this work? After the teacher starts a test session for students, the students can access the interim assessments on a nonsecure website with either the Chrome or Firefox browser. Accessing the interim assessments will be available through June 30, 2020.
