

- Live teaching
- Organization of the Google Classroom
- Communication and Feedback

Our Response and Current Feedback

- Supported live meets for ELA and Math, Morning Meetings
 - #1 improvement live meets (81.7%)
- Implemented a required organization of Google classroom and daily agenda
 - #2 improvement Google Classroom organization (61.1%)
- Focus on continuous feedback to students and families
 - #3 improvement Increased communication from teacher (39.7%)

Most Effective Actions for Learning

• Live teachinglessons

- Teachers are creating structures, routines, and expectations
- Modeling the Learning Target and discussing Success Criteria
- Meeting teacher in small groups
 - Differentiated instruction, gives students more interaction

• Feedback on my work

- Students show their teacher what they learned, opportunities for growth
- Teachers are assessing to guide their practice
- Whole class meetings
 - Teachers are building relationships and sense of community



Small Cohort and In-Person Assessments

- Assessed all English Learner students that qualified for initial English Language Proficiency Assessment for California (ELPAC) at all school sites
- Currently engaging families who have students who have an IEP or need to be assessed for an IEP for in-person assessments, if they are comfortable proceeding
- Launching targeted cohorts of students in our SHINE program at Old Orchard and our Severe SDC program at Pico Canyon on October 26th

Cyber Security Update

Cyber AttackEvent

- Incident occured on September 14, 2020
 - Temporarily lost access to several district laptops, desktops and servers
- Upon discovery the following steps were implemented:
 - Servers and devices were turned off
 - Synchronous instruction was cancelled for the day, 100% asynchronous instructional plans started the following day
 - 3rd party forescensic team was retained
- Scope of Forensic Team:
 - Investigate incident
 - Determine scope of the incident
 - Assist with restoration efforts

Cyber Security Update

Restoration Process

- First priority was to restore synchronous instruction
 - Student devices were inspected and if necessary received an additional layer of protection during material distribution at each school site
 - Synchronous instruction resumed September 23, 2020
- Focus shifted towards restoring access to data and systems

Investigation Process

- Still an active investigation
 - At this point there is no evidence staff or student data has been lost, stolen or misused
 - The District will follow any actions deemed necessary at the conclusion of the investigation
 - The District will continue to send out communication as information becomes available



Cyber Security Update

Improvements to Date

- Purchase of three new servers
- Stronger requirements for authentication
- Incorporating stronger security practices as we rebuild

Next Steps

- Implement best practices identified through the investigative process
- Provide staff training on best practices
- Continuously Improve our network equipment and security
