# **Continuous Learning Opportunities**

Last Friday afternoon, our teachers went above-and-beyond the call to create continuous learning opportunities for all students across the District during this extended school closure. Students receiving specialized academic instruction (SAI) through the Resource Specialist Program (RSP) or mild/moderate Special Day Class (SDC), please be advised that the continuous learning opportunities posted on school websites were generated in collaboration with special education and general education teachers.

# **School Lunch Program**

Additionally, Rancho Pico JHS, La Mesa JHS, Arroyo Seco JHS, and Rio Norte JHS will provide a free lunch between 12:00-1:00. We encourage our families to take advantage of this opportunity, as it is open to <u>ALL</u> students!
